Release/Indemnification/Assumption of Risk

In consideration for participation in the Herding Instinct Test/Lesson or other event held by Lisa Edwards or Sage Wind Ranch. I (we) agree to assume all responsibility for any claim, loss or damage of whatever kind or nature, whether to person or property, which may be caused at or near the site, either directly or indirectly, by me (us) or the dog or dogs I (we) have brought to the site. I further agree that I will hold Lisa Edwards and any assistants or agents, heirs, successors, and assigns (collectively Lisa Edwards), the Sage Wind Ranch and its owners, tenants, or lessees, and their agents, heirs, successors, and assigns (collectively Sage Wind Ranch) harmless and defend them against any and all liability for injury, claim, damage or loss of whatever kind or nature, whether to person or property, caused by myself (ourselves) or my (our) dog or dogs at or near the site.

I agree to indemnify Lisa Edwards, and the Sage Wind Ranch, for any cost or expense, including attorney fees and costs, which might result from any claim, suit, loss or damage caused in any way by any act of negligence on my (our) part or on the part of any dog or dogs I have brought to the site.

I (we) certify and represent that the dog or dogs I (we) have brought to any Herding Test Trial, Lesson or other event is/are not a hazard to other dogs, other animals, or to people. I (we) agree to pay for injuries or replacement value in the event of death of any livestock caused by my (our) dog or dogs. I (we) agree to pay full market value for the injured animal in case of injury, or the veterinary expenses incurred due to the injury, at the discretion of the livestock's owner.

I (we) acknowledge that the sport of herding is inherently dangerous and holds the risk of damage or injury to myself (ourselves) and my (our) dog or dogs or other property. I agree to assume all risks of injury or damage to myself (ourselves), our dog or dogs, or other property, incurred on or near the site before, during, or after any Herding Test, Trial, Lesson, or other event, to waive and release any claims or liability against Lisa Edwards, and the Sage Wind Ranch, whether or not caused by negligence on their part or parts or on the part of a third person or persons, and to hold Lisa Edwards and the Sage Wind Ranch harmless from injury, claim, damage or loss of whatever kind or nature, whether to person or property, whether caused by accident or by negligence on their part or parts or on the part of a third person or persons at the site or traveling to or from the site.

I (we) agree that any disputes or claims arising from my participation in any Herding Test, Trial, Lesson, or other event or from this release shall be brought in the State of Nevada and shall be governed by the laws of the State of Nevada.
