FROM SOUTH; Take Hwy. 395 to Gardnerville. At the traffic signal at Hwy 395 & Waterloo Lane, turn right onto Waterloo.

FROM NORTH: Take Hwy. 395 to Gardnerville. At the traffic signal at Hwy. 395 & Waterloo Lane, turn left onto Waterloo.

(Waterloo street name changes to Toler Ave., and then to Fish Spring Road).

Travel approximately 6 miles to Windmill Road, turning left onto Windmill. Go ¾ mile to the herding facility at the corner of Windmill & Sheena Terrace. Turn right on Sheena Terrace to ranch entrance just past the first house on the right. Signs will be posted.
