Directions to ¾ Circle H Ranch from the north - Reno/Sparks area:

Take I580 / 395 South to Carson City where I580 ends. Exit and turn right onto Fairview Drive (to 395/50). Turn left onto S. Carson St. (395 / 50) and continue south on 395 to Minden/Gardnerville.

Turn right onto Hwy #756 (at the stoplight at Sharkey's Casino). Go 1.5 miles.

At the 4-way stop, turn left onto Dresslerville Rd. Go .6 mile to 1350 Dresslerville Rd. and turn left under the arches into lane; follow signs, parking area is on the left.

Directions to ¾ Circle H Ranch from the northwest (Highway #88):

Turn right onto Centerville Lane (Highway #756).

Continue on #756 (turn left at 4-way stop, follow sign to Golf Course)

At the 2nd 4-way stop, go straight onto Dresslerville Rd. (#756 turns left again)

Go .6 mile to 1350 Dresslerville Rd. and turn left into lane; follow signs to parking area on the left.

Directions to ¾ Circle H Ranch from the southwest (Highway #395):

Turn left onto Riverview Rd at the 7-11 Gas Station; continue past the golf course.

This road turns into Dresslerville Rd.

Continue (a few miles) to 1350 Dresslerville Rd. and turn right into lane; follow signs to parking area on the left.
